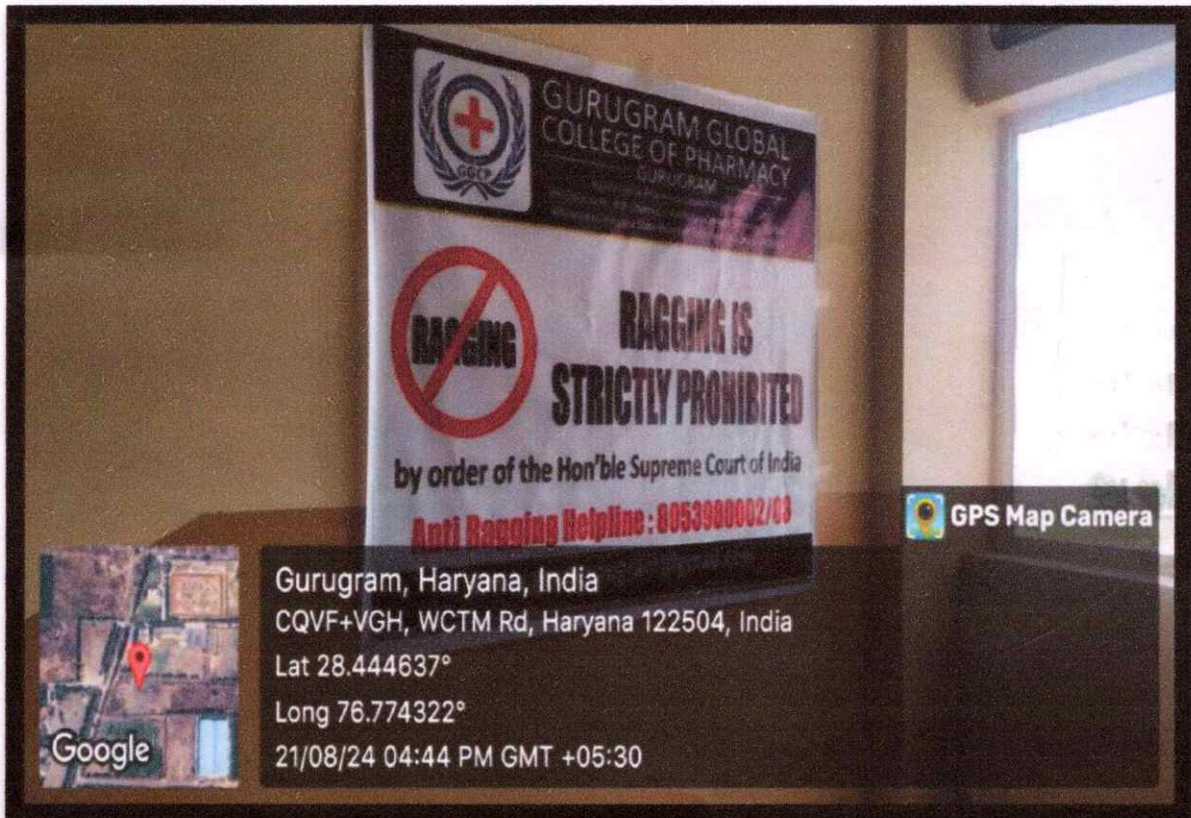

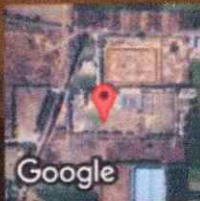

Principal Dr. Indira Raheja, Gurugram Global College of Pharmacy organized the webinar on "*The impact of Sexual Harassment on Mental Health and Well -being*" on 26th August 2020 through online platform. The session began with a warm welcome of all the delegates and kind introduction of highly experienced and speaker of the day.

The session began by brief introduction about Sexual harassment issue that affects individuals across various environments, including workplaces, educational institutions, and public spaces. She also talked about the psychological effects of sexual harassment, exploring the short-term and long-term consequences on victims, and the importance of providing appropriate support and intervention. Sexual harassment can take many forms, including: inappropriate comments, jokes, or remarks of a sexual nature; displaying sexually explicit materials; Unwanted touching, groping, or physical advances. These behaviours can create a hostile environment, leading to significant distress for the victims.

At the last Dr. Indira Raheja concludes that: by understanding the profound effects of harassment and taking proactive measures to prevent it, institutions and organizations can create safer, more supportive environments for everyone.

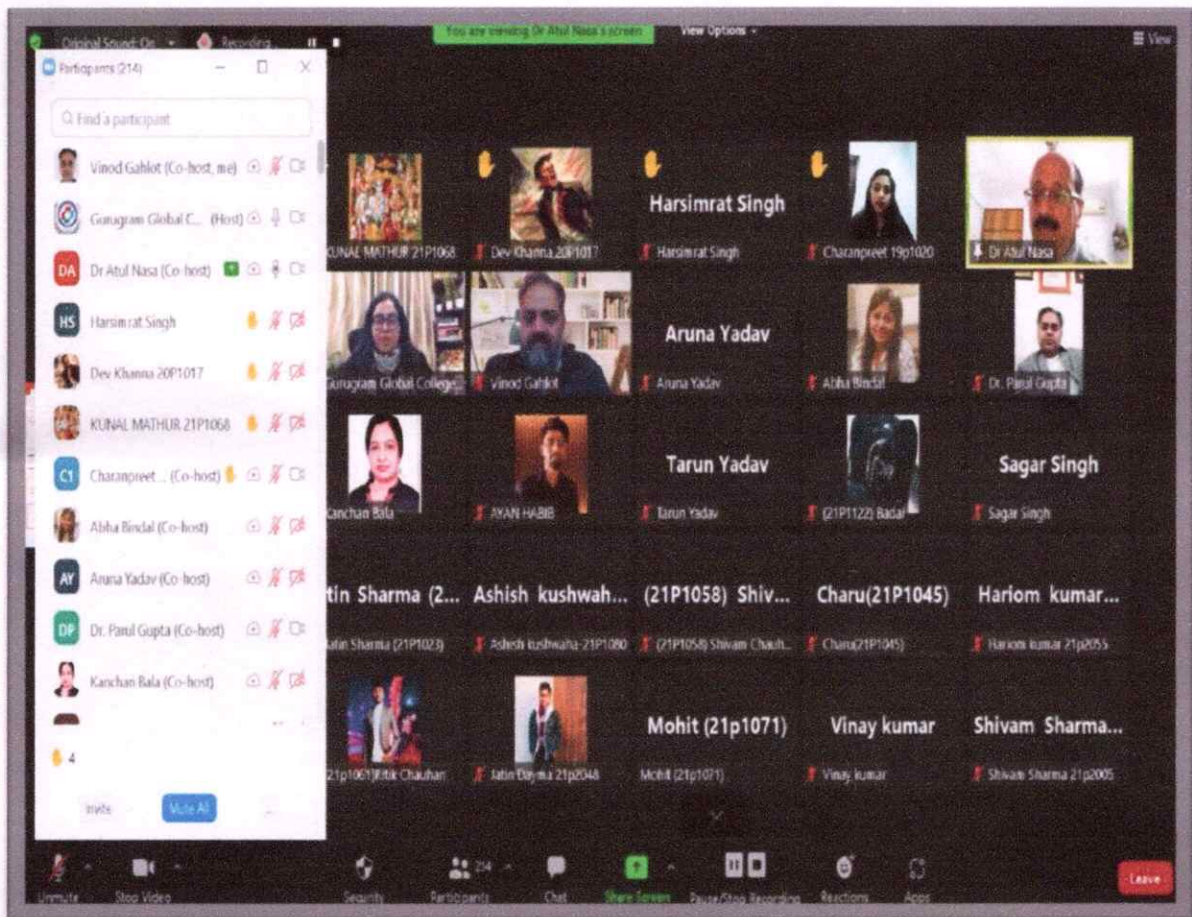
