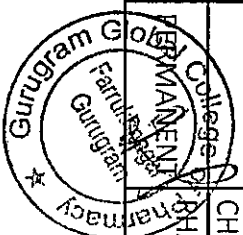

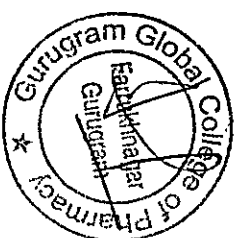

LETTER OF APPOINTMENT

In continuation to the offer letter issued vide its No. _____ Dated 01/07/2017 subsequent of His /her acceptance of the offer of appointment Sh./Smt./Ms. Dr. Indira Rajeja hereby appointed as Principal on purely temporary basis in the pay scale of Rs. 37400-67000 ACP-10000 plus usual allowances as admissible from time to time initially for a period of one year extendable further subject to the approval of the management in writing.

The terms and condition of appointment are as under:-



1. On appointment, he/she will draw basic salary of Rs. 37400 - 67000/- in the said scale of plus usual allowances as per the norms approved by UNIVERSITY/AICTE/PCI from time to time.
2. The appointment is purely temporary on probation and contingent in nature and not against any substantive post. The period of probation is initially for a period of one year. Probation may be his /her appointment. The decision of the Appointing Authority/Management will be final and binding. He/she will continue to be on probation until and unless confirmed in writing.
3. During the period of probation, the services can be terminated by the Appointing authority or the appointee by giving one month's notice. However, the Appointing Authority reserves the right to terminate the services of the probationer henceforth by paying him/her a sum equivalent to the working period of one month. But in case the service of the probationer is terminated on some disciplinary grounds, no such payment shall be payable by the Appointing Authority.
4. He/she can be assigned any administrative and/or supervisory duties in addition to his/her duties by the college/Baljeet Singh Education Society (hereinafter referred to as BSES) without any extra remuneration. He/she is liable to be posted in any of the offices of the college/BSES and to work in any of its departments. The decision of the College/BSES will be final and binding. Refusal to obey the orders in this regard would result into disciplinary action.
5. His/her services will be governed by the rules and regulations of the College as amended from time to time.

6. He/she will be solely responsible for the safe custody of all the book, teaching material, registers and other material of the College and shall return all the items in good condition at the time of his/her termination/leave the services. In case, any of the item (S) is/are found to have been lost and/or damaged due to his/her negligence, an amount equivalent to the cost thereof will be recovered from his/her salary/other dues.
7. He/she will communicate immediately any change in his/her residential address, to the College failing which any communication is sent to his/her available address, it shall be deemed to have been delivered at his/her address.
8. Casual leave, which is not accumulated, can be availed by him/her during the current calendar year with prior intimation but the same can not be availed as a matter of right and can be refused by the authority/management in case of an emergency and/or if so required in the interest of the Institution.
9. No leave will be admissible without the prior written permission of the competent authority.
10. He/she will not leave the College /BSES in the middle of semester and that he/she shall not directly or indirectly carry on and/or be interested and/or be employed in any other College /organization during his service period in this College /BSES.
11. He/she shall abide by the code of conduct as in force or may be enforced from time to time by the College /BSES. He/she shall also maintain secrecy of information(s) of the College /Management.
12. His/her continuation of appointment will be subject to his/her being declared mentally/physically fit by the doctor so appointed by the College /BSES for the purpose. The decision of the doctor will be final and binding.
13. His/her appointment will be further subject to the verification of his/her character and antecedents. He/she will have to file an affidavit to the effect that he has never been dismissed from service or in any case in filed/pending in any police station or court of law and that he/she had not been arrested/prosecuted/put under detention/bound down/fined/convicted by any court of law for any offence.
14. He/she shall produce his/her original certificates in support of his/her educational, academic and technical qualification(s), which render him/her qualified for appointment to the post.
