
Brief content of the event:



For more than six decades, **Sham Lal Nasa** has borne witness to many changes in India's pharmaceutical industry and pharmacy education. One of the founder members of the Indian Pharmacy Graduates' Association (IPGA) and Indian Hospital Pharmacists Association, Sham Lal Nasa has contributed in no small measure to the present-day stature of India's pharmaceutical industry By helping to shape pharmacy education policy, he has tried to ensure that academia keeps pace with industry needs. This characteristic of the pharma industry in India has strategic importance, because as he says, "These units produce drugs that are not under patent protection and are analogous to products that are already present in the market Hence competition is severe among pharma units in India, which is one of the important reasons for the relatively lower prices of medicines in India. At present there are around 16000 manufacturing units in the country of which 300 are in the organised sector." SL Nasa is clear that this growth of the Indian pharma industry prior to the new intellectual property regime was due to a favourable patent policy, i.e. the Patent Act, 1970 which provided ample opportunities for the growth of domestic pharma companies.


